- **1.** To note that on (date) the Cabinet calculated the Council Tax Base 2024/25 to be 53,322 properties.
- 2. To determine that the Council Tax requirement for the Council's own purposes for 2024/25 is £91,266,612.
- **3.** That the following amounts be calculated for the year 2024/25 in accordance with Sections 31 to 36 of the Local Government Finance Act 1992, as amended (the Act):
- (a) £410,150,512 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (2) of the Act
- (b) £318,883,900 being the aggregate of the amounts which the Council estimates for the items set out in Section 31A (3) of the Act
- (c) £91,266,612 Being the amount by which the aggregate of 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year
- (d) £1,711.62 Being the amount at 3(c) above, divided by the Council Tax
 Base shown at 1 above, as the basic amount of its Council Tax
 for the year (including town/parish precepts)
- (e) £0 being the aggregate amount of all special items (Parish precepts) referred to in Section 34(1) of the Act.
- (f) £1,711.62

 Being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by the Council Tax Base shown at 1(a) above, calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Town Parish precept relates.
