# **1.0 EXECUTIVE SUMMARY**

- 1.1 The overall direction of travel in respect of all the indicators that the Council measures itself against is positive with:
  - 62.4 % improving over 2009/10
  - 8.0 % remaining static
  - 29.6 % declining in performance over 2009/10
- 1.2 The overall direction of travel in respect of indicators featuring in the Annual Report relating to the **Cleaner, Greener and Safer** agenda is
  - 61.54 % improving over 2009/10
  - 15.38 % remaining static
  - 23.08 % declining in performance over 2009/10

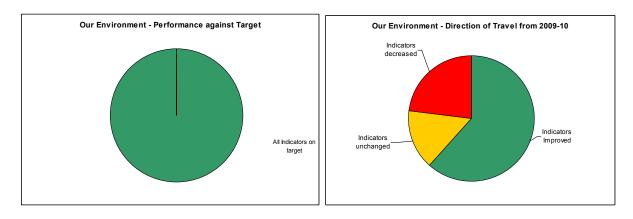
## 2.0 INTRODUCTION AND BACKGROUND:

- 2.1 Whilst considering the Annual Report 2010-11, the Corporate Overview and Scrutiny on 13 September 2011 recommended that each Overview and Scrutiny Committee receive a report outlining the parts of the Annual Report that relate to the areas within their scope of interest.
- 2.2 This report presents a review of performance based on the outturns of performance indicators during the 2010/11 municipal year. The data table can be found at Appendix 1.

#### 3.0 The Performance Report Headlines

- 3.1 Below is a trend summary of the indicators contained within this report which relate to the **Cleaner, Greener & Safer** scope of interest.
- **3.2 Performance against target** of the 13 indicators that are comparable
  - **100** % met their target ie GREEN
- **3.3** Direction of Travel of the 13 indicators that are comparable:
  - 61.54 % improved on the previous year's outturn
  - 15.38 % remained static
  - 23.08 % declined

#### 4.0 Environment / Cleaner, Greener & Safer Headlines



Of the 13 performance indicators that measure environmental outcomes the highlights include:

- The percentage of municipal waste being sent for landfill reduced from 61.6% to 34.26%;
- The percentage of household waste sent for reuse, recycling and composting increased from 36.3% to 46.16%;

 Street and environmental cleanliness indicators met their targets with levels of detritus and graffiti reducing

#### Improvement Focus:

• Across the board in Environment, performance against targets was excellent. Given the financial constraints that the departments are currently under, and the need to find additional savings, it is unlikely that there will be further similar improvements this year. Aspirational targets have been set for street cleansing and recycling for 2011/12.
