EXECUTIVE SUMMARY

Summary of Emerging Priorities and plans for 2011/12

In 2011/12 the Partnership agreed it's priorities for 2011/14

- Reduce Anti-social Behaviour
- \circ Improve community safety through Education, Engagement and Prevention \circ Reduce re-offending
- o Reduce Serious Crime, including sexual offences and Domestic Abuse
- o Tackle Hate crime (race, disability, sexual orientation and religion)

The strategic assessment which has been carried out indicates that the priorities are still valid and a continuing focus is required on anti-social behaviour, educating residents to prevent acquisitive crime (burglary and car crime), domestic abuse and hate crime.

Some of the data used in the formation of the strategic assessment comes from iQanta. Figures from iQuanta are provisional and subject to further quality assurance. They are not to be used in the public domain before quality assured figures are published as National Statistics. These figures are therefore not part of this report, although some conclusions within the report may have been formulated from this data.

1. **RECOMMENDATIONS:**

That members recommend that Thurrock Community Safety Partnership Board agree the following recommendations

- 1.1 Thurrock Community Safety Partnership continue to prioritise serious crime and anti-social behaviour and domestic burglary volume crime
- 1.2 That the Thurrock Community Safety Partnership alcohol strategy is implemented as a priority to address the increasing violent crime.
- 1.3 Distraction burglary, whilst being low volume, often goes unreported and affects the most vulnerable in the community. It is recommended that TCSP continue to promote prevention in relation to this crime in order to prevent another increase in this crime.
- 1.4 Integrated Offender management needs to be a priority to embed over the coming year to address re-offending
- 1.5 Locality Action Groups should continue to target offenders of ASB and safeguard our vulnerable people.
- 1.6 Awareness raising in relation to hate crime, in particular around disability should continue.
- 1.7 Violence against women needs to have a stronger focus, in particular ensuring that we link into the work in children's services which Professor Kelly is leading on and we need to look at how we commission our services aligning ourselves to the Council's process and working closer with Essex.
- 1.8 Thurrock Community Safety Partnership continue to promote and work with the illegal money lending team to determine the extent of loan sharks in Thurrock and work to identify perpetrators and support victims of this crime.
- 1.9 The Olympics and PREVENT agenda need to have a strong focus for the first 6 months of 12/13.

2. INTRODUCTION AND BACKGROUND:

- 2.1.1 Part of the role of the crime and disorder overview and scrutiny committee is to contribute to the development of strategies and to examine the performance of the partnership.
- 2.1.2 This summary report of our strategic assessment for 2011, will provide the committee with an overview of the current situation and recommendations for sustaining / improving our performance over the coming months and years.

 - Undertake annual reviews and plan activity based on a clear understanding of the issues and priorities.

3.5 Headline Statistics from TCSP Strategic Assessment 2011

- 3.5.1 All data comparisons are between 1st Apr 09 31st Mar 10 and 1st Apr 10 31st Mar 11, unless otherwise stated.
- **3.5.2** Figures for 2010/11 for Thurrock show a 5 per cent ¹ reduction in crime (6,338) which compares to an average 8 per cent fall in England and Wales. Crime in Essex fell by 4 per cent.
- **3.5.3** The figures show that in Thurrock there are 40 crimes committed per 1,000 population which is lower than the national average of 41 per 1,000.

- **3.5.4** Whilst Thurrock maintained a downward trend on overall crime for the year 2010/11 figures for the year 2011/12 are already giving rise for concern.
- **3.5.5** Whilst this assessment focuses on the year 10/11 TCSP are carefully monitoring this years crime trends and reacting and reviewing priorities.

3.6 Summary of Emerging Priorities and plans

- **3.6.1** Serious acquisitive crime in particular Domestic Burglary which has shown an increase in 10/11 & vehicle crime which continues to be high volume.
- **3.6.2 Violent crime** is an increasing problem in Grays and is linked in many cases to alcohol
- **3.6.3** Theft Other is a key emerging crime which is increasing, linked primarily to metal thefts.
- **3.6.4** Anti-social behaviour whilst reports are falling this continues to be resident's primary concern, in particular youth nuisance. West Thurrock and Grays Riverside are the priority wards.

- **3.6.5** The Partnership notes that **sexual violence** continues to be an under reported crime and will be working closely with South Essex Rape and Incest Crisis centre (SERICC) in delivering the Violence Against Women Strategy
- **3.6.6** Domestic Abuse continues to be cause for concern with an increase in reporting and the ability for services to meet demand.
- **3.6.7 Hate crime** is an under reported crime, in particular against those with a disability. TCSP need to continue to work with Thurrock Disability Network and the Learning Disability Partnership as well as Essex gay men and The Coalition to ensure that vulnerable residents are able to report abuse.
- **3.6.8 Distraction burglary** increased at the start of this year and there needs to be a constant awareness raising of this issue amongst the most vulnerable members of our community
- **3.6.9** Adult **re-offending rate** has reduced in 2010/11 by 5.6% which is positive compared to Essex at +2.78%. Reduction in PPO re-offending of -21.37% compares favourably to national at -14.55%, but not as good as Essex at -31.47%.
- **3.6.10** The **DAAT** continues to deliver excellent performance with 234 Opiate & Crack Users (OCUs) in effective treatment in May 2011.
- **3.6.11** The **Loan shark** campaign has been launched and reports are now starting to come in. This campaign needs to continue targeting the deprived areas of our community.
