<b>Impact of Proposal on public / services</b>	<p>The work of the current Trading Standards team on the issues highlighted in the alternative proposal focuses on the underage sale of alcohol and cigarettes to young people in Thurrock. The influence of the Trading Standards team on obesity is less direct, this work being done in the main by others including the Food Safety team. The proposal to increase the budget for Trading Standards has to be weighed against the overall budget position for the authority and the impact of any increase on the money available to other services in the authority.</p>

<b>Impact of Proposal on performance</b>	<p>The amount quoted above would allow for the recruitment of an additional Trading Standards Officer. This would allow for a dedicated officer to be assigned to underage sales work to address the issues highlighted in the JSNA around alcohol and tobacco. This would provide for an increased interaction between local businesses selling alcohol and tobacco and the enforcement authority. This could be used for business education as well as enforcement against traders who flout the regulations. The disruption of supply of age restricted products such as alcohol and cigarettes to young people in Thurrock would have a beneficial effect on their long-term health and potentially on their educational prospects.</p>
