Is the Portfolio Holder confident that the maintenance of council maintained roads is adequate and ensures road users safety?

## 4. From Councillor Anderson to Councillor Holloway

We have already seen floods this winter, but not yet experienced the first major freeze of 2014. Is the council adequately prepared to deal with snow and ice when the bad weather arrives?
