1. From Councillor Hebb to Councillor A Smith

On 28-01-2014, a horrendous motor vehicle accident occurred on the bend leading into Wharf Road on The Green, Stanford-le-Hope,

Can the Portfolio Holder please detail what steps are being taken to address this hazardous turning, in terms of accident prevention?

2. From Councillor Hebb to Councillor B Rice

The Portfolio Holder will be aware that successful recruitment for social care roles can be difficult. This is sometimes not helped by unattractive salaries; unsociable working hours and the intense pressure of the role itself.
