

To the principal licensing officer

I am writing to you with my objection to the proposed fare increase in the hackney carriage tariff.

My objections are as follows

During the month of may 2012 myself and 26 others hackney carriage drivers put a proposal to the taxi association requesting a fare increase the details we requested are as follows

Tariff 1... 50p increase on flag fall from 2.30 to 2.80

Tariff 1... To run from 06.00 instead of 07.00 hours till 23.00 monday - saturday

Tariff 2... No increase at all even flag fall stayed at 3.30, and this tariff to run from 23.00 - 06.00 inc sundays and bank holidays

Tariff 3... No increase, flag fall to remain at 4.00, but times to be changed when this tariff is operative

The timings of the tariffs we proposed to association was

Rate 1 monday - saturday 06.00-23.00

Rate 2 monday - saturday 23.00-06.00

the xmas and new year period was to be as follows

24th dec @06.00= rate 1

24th dec @18.00= rate 2

24th dec @23.00= rate 3 until 06.00 on the 26th when it reverts back to rate 2 until 06.00 on the 27th(unless 27th is a bank holiday then it would stay on rate 2 until 06.00 the following day)

31st dec @06.00= rate 1

31st dec @18.00= rate 2

31st dec @23.00= rate 3 until 06.00 on the 1st january when it reverts back to rate 2 until 06.00 on the 2nd unless this is a bank holiday then it will stay at rate 2 untill 06.00 the following day

Looking at the proposal that has been sent to me none of this is evident, not sure who has made the mistakes with the new proposal so i would like to object this proposal so that it can be rectified

Also please note there is no objection to the new tariff for minibus and mpv rate for over 4 passengers

3. It is better to decrease the price of a plastic badge per year, rather than changing the rule and put the price up and charge us a massive amount of money for renewing our badge.
